## Call for Program Proposals

36th Annual Meeting of the Jean Piaget Society


June 1–3, 2006, Sheraton Inner Harbor Hotel, Baltimore, Maryland


**Submission deadline November 15, 2005**

Scholars interested in the development of knowledge are invited to participate, whatever their discipline. The plenary sessions will be organized around a general theme, but individual proposals do not have to be related to that theme.

### General Theme

This year's meeting, *Art and Human Development*, will explore themes of creativity, invention, and the world of the imagination. Contributors to the invited program will challenge realist epistemologies that view the products and processes of imagination as exotic departures from development's more serious course of adaptation and acquisition of "objective" knowledge. Instead, they will advance the argument that understanding human development may be furthered through an analysis of creative activities such as stories, paintings, music and myths. In addition, they will suggest that interpretive perspectives common to the disciplines of history, art, and literary criticism, can provide appropriate source-models for the developmental sciences. Plenary speakers will include **Murray Forman** (Northeastern University), **Norman Freeman** (University of Bristol), **Carol Lee** (Northwestern), **David Lewis-Williams** (University of Witwatersrand), and **Ellen Winner** (Boston College). The program will also feature a special evening panel of artists and a seminar on Piaget's, *Possibility and Necessity: Volume 1, The role of possibility in cognitive development*.

## Submission Formats

### Paper

Paper presentations (15 minutes) may be focused on either empirical findings or theoretical analysis. The program review committee will select individual submissions and schedule a series of Paper Sessions that include 3-5 papers on similar topics. These sessions will have a moderator and perhaps a discussant appointed by the program committee. A paper proposal should include a 200 word abstract (for publication in the conference program) and a 1000 word summary (for the program review committee).

### Symposium Session

Symposium proposals (75-90 minutes) should describe 3-4 presentations organized around a single topic. Symposium sessions will have a named organizer who may serve as moderator, and may include a named discussant who will comment on the presented papers. A symposium proposal should include a 400 word abstract (for publication in the conference program), and a 1500 word summary (for the program review committee) that describes each of the presentations and the session as a whole.

### Submission Requirements

### Poster

Poster presentations may be focused on either empirical findings or theoretical analysis. The conference usually holds two poster sessions held on separate days. The sessions are organized around broad themes derived from the 40-50 posters selected for each session. Posters are mounted for display in a high-traffic area for the entire day of the session, but presenting authors need only attend their poster during the official session near the end of the day. A poster proposal should include a 1000 word summary for the program review committee.

### Discussion Session

Discussion Sessions (75-90 minutes) are intended to provide an interactive venue for exploring ideas that bear on the development of knowledge, broadly conceived. They may be formatted as debates, panels, or organized discussions; and may focus on any well-defined topic. Submissions should include a 400 word abstract (for publication in the conference program), and a 1000 word summary (for the program review committee) that describes the topic and structure of the session and the role of each of the discussion leaders.

- 1 All presenters must register for the meeting.
- 2 Individuals may not be listed as authors on more than two presentations.
- 3 Presentations must not have been presented at any other meeting having the same general audience as the Jean Piaget Society.

*To be considered, proposals must be received (not just post-marked) by November 15, 2004.*
